He has co-authored the Erosion and Sediment Control Guidelines for State Highway Infrastructure for the New Zealand Transport Agency (August 2010), Scientific basis for Erosion and Sediment Control practices in New Zealand for Tasman District Council (2016) and was a contributing author of the guideline document 2016/005, known more commonly as GD05.

#### Queenstown Lakes District Monitoring and Enforcement Sam de Reeper & Ashlin Woodley - Monitoring, Enforcement & Environmental Officers, Queenstown Lakes District Council



Sam and Ash are part of Queenstown Lakes District Council's Monitoring and Enforcement team. Their roles include administering the provisions in the Resource Management Act 1991, Building Act 2004, Local Government Act 1974 and many more pieces of legislation. They will cover the legislative framework behind the work they undertake within the environmental space, and some common issues they see on site.

Currently on the Board of Directors and Vice President for the IECA Australasian Chapter, Joe originally started as a Territory Manager for PGG Wrightson Turf where he became a specialist in hydraulically applied erosion control products. Joe's key focus and passion is around the environmental sector where he has worked closely with the likes of CERA (Canterbury Earthquake Recovery Authority) and provided specialist advice on revegetation and erosion control. This led to the specifications of new hydraulically applied technologies for revegetation in difficult terrains in the Christchurch earthquake reclamation work.

#### 12.15pm Marshlands Bridge environmental challenges Dathan Proudlove - Head of Environment & Sustainability (TREC), Downer NZ

Bringing with him a wealth of experience, Dathan has been able to take time out of his busy schedule to speak about the challenges that were faced by his team during the Marshlands Bridge upgrade in Christchurch. Dathan has 12 years of environmental management experience and has worked on the Christchurch Earthquake Rebuild, along with a number of other construction projects valued from 10 million to 200+ million dollars within New Zealand.

#### Earthworks and the weather – How can we better prepare? Stephanie Kirk - Environmental Manager, Takitimu North Link, HEB Construction

Stephanie Kirk has spent almost 10 years in the environmental, earthworks, and erosion and sediment control space. Working for councils, clients, and contractors, she has seen all sides of the earthwork's regulatory framework, from planning to on the ground implementation. Stephanie is currently the Environmental Manager for the \$655 million-dollar large-scale infrastructure roading project, Takitimu North Link, in Tauranga.

With the wettest earthworks season on record in Tauranga last year, Stephanie will be talking about the challenges of working on a large earthworks project with record breaking rainfall, and the innovative weather forecasting software her team has been using from NIWA. Stephanie's work with NIWA was an earthworks industry first and this project won the International Erosion Control Association Australasia's award for 'Innovation, contribution and collaboration to the Erosion and Sediment Control industry'.

She will outline how their erosion and sediment controls have stood up to the test, highlight some of the tough challenges they have face along the way, and explain how they have remained on side with the regulatory authorities throughout the process.
